CHAPTER V

CONCLUSION

This chapter discusses the conclusion of the previous chapter's analysis. The study has two objectives. The first is a description of the Divergent novel's factions, and the second is a class struggle between the Divergent novel's factions.

The first goal is to provide a synopsis of the Divergent novel. The first discovery is that Divergent's society is organized around a faction system. Society is divided into five factions based on human virtue. The factions are Abnegation, Candor, Erudite, Amity, and Dauntless. Each faction has its own manifesto, role, and contribution to society. All sixteen-year-olds must choose one of the factions in which they will serve for the rest of their lives.

In addition to the five previously mentioned factions, there is Factionless. Factionless refers to people who do not belong to any faction and have not been initiated into the faction of their choice. Divergent is an addition to the five factions and the factionless. The Divergent is intended for individuals whose aptitude test results are inconclusive. According to the Erudite, the Divergent is a dangerous thing because people who are Divergent belong to more than one faction and cannot be confined to one way of thinking. For this reason, the Erudite directs the Dauntless to execute the Divergent.

In the Divergent novel, the second goal is class conflict among factions. Prior to reaching the stage of class struggle, the Abnegation faction as an oppressed faction is aware of their situation and position in society. The realization motivates the act of class struggle, or the struggle to defeat capitalism and oppression. In this case, as an opposing faction to the Erudite, the Abnegation fights against the Erudite in order to be

free of capitalism. Finally, the Abnegation faction's struggle not only liberates them from capitalism, but also causes Divergent society to shift from faction society to factionless society.
