

BAB V

PENUTUP

A. Kesimpulan

Dari hasil penelitian yang telah dilakukan maka kesimpulan yang diperoleh adalah sebagai berikut :

1. Secara parsial penelitian ini menunjukkan bahwa terdapat pengaruh signifikan antara profitabilitas (*return on assets*) terhadap manajemen laba perusahaan subsektor *property* dan *real estate* yang terdaftar di Bursa Efek Indonesia tahun 2013-2017.
2. Secara parsial penelitian ini menunjukkan bahwa tidak terdapat pengaruh signifikan antara *leverage (debt to assets ratio)* terhadap manajemen laba perusahaan sub sektor *property* dan *real estate* yang terdaftar di Bursa Efek Indonesia tahun 2013-2017.
3. Secara parsial penelitian ini menunjukkan bahwa terdapat pengaruh signifikan antara ukuran perusahaan terhadap manajemen laba perusahaan subsektor *property* dan *real estate* yang terdaftar di Bursa Efek Indonesia tahun 2013-2017.
4. Secara simultan penelitian ini menunjukkan bahwa terdapat pengaruh signifikan antara profitabilitas (*return on assets*), *leverage (debt to assets ratio)* dan ukuran perusahaan terhadap manajemen laba pada perusahaan subsektor *property* dan *real estate* yang terdaftar di Bursa Efek Indonesia tahun 2013-2017.

B. Implikasi

Hasil dari penelitian pengaruh profitabilitas, *leverage* dan ukuran perusahaan terhadap manajemen laba pada perusahaan subsektor *property* dan *real estate* yang terdaftar di Bursa Efek Indonesia (BEI) periode 2013-2017 memberikan kesimpulan seperti di atas, maka implikasi bagi masyarakat terhadap penelitian ini, yaitu:

1. Bagi akademisi, penelitian ini diharapkan dapat menjadi referensi bagi penelitian selanjutnya. Dengan mempertimbangkan beberapa faktor penting dalam penelitian ini. Selain itu, diharapkan penelitian selanjutnya dapat menambahkan variabel lain yang berbeda yang diperkirakan mempunyai pengaruh terhadap manajemen laba dan melakukan penelitian dengan sektor yang berbeda.
2. Bagi investor, penelitian ini diharapkan dapat dijadikan sebagai input informasi terkait dengan pengambilan keputusan didalam investasi sehingga investor dapat mengambil keputusan secara efektif dan efisien agar perusahaan menjadi lebih baik dan berkembang setiap tahunnya.
3. Bagi perusahaan, penelitian ini diharapkan dapat bermanfaat bagi perusahaan, khususnya manajemen perusahaan, hasil penelitian ini diharapkan dapat menjadi bahan pertimbangan dalam pengambilan keputusan dalam mengelola perusahaan dan membuat perusahaan lebih baik dan maju.

C. Saran

Berdasarkan hasil kesimpulan di atas maka penulis memberikan saran sebagai berikut :

1. Bagi pemakai laporan atau para analisis yang akan mengambil keputusan terhadap manajemen laba perusahaan hendaknya tidak hanya memperhatikan variabel profitabilitas (*return on assets*), *leverage (debt to assets ratio)* dan ukuran perusahaan tetapi perlu juga memperhatikan rasio keuangan lainnya dan faktor-faktor lain yang berhubungan dengan manajemen laba perusahaan, seperti faktor ekonomi atau nilai perusahaan, efek industri dan lainnya.
2. Bagi perusahaan, diharapkan untuk dapat mengelola aset atau persediaan dengan efektif, meningkatkan penjualan produk perusahaan, mampu mengelola pendapatan yang diterima perusahaan dengan baik dan benar sehingga terjadi keseimbangan antara pendapatan dengan biaya yang dibayarkan perusahaan selain itu dapat memperluas perusahaan jika hal tersebut dapat dikelola dengan baik dan benar.
3. Bagi penelitian selanjutnya dapat melakukan penelitian dengan menambah sampel lebih banyak lagi dengan berbagai kriteria lainnya dan menggunakan rasio keuangan yang lainnya sehingga hasil penelitian memiliki distribusi data yang lebih baik.

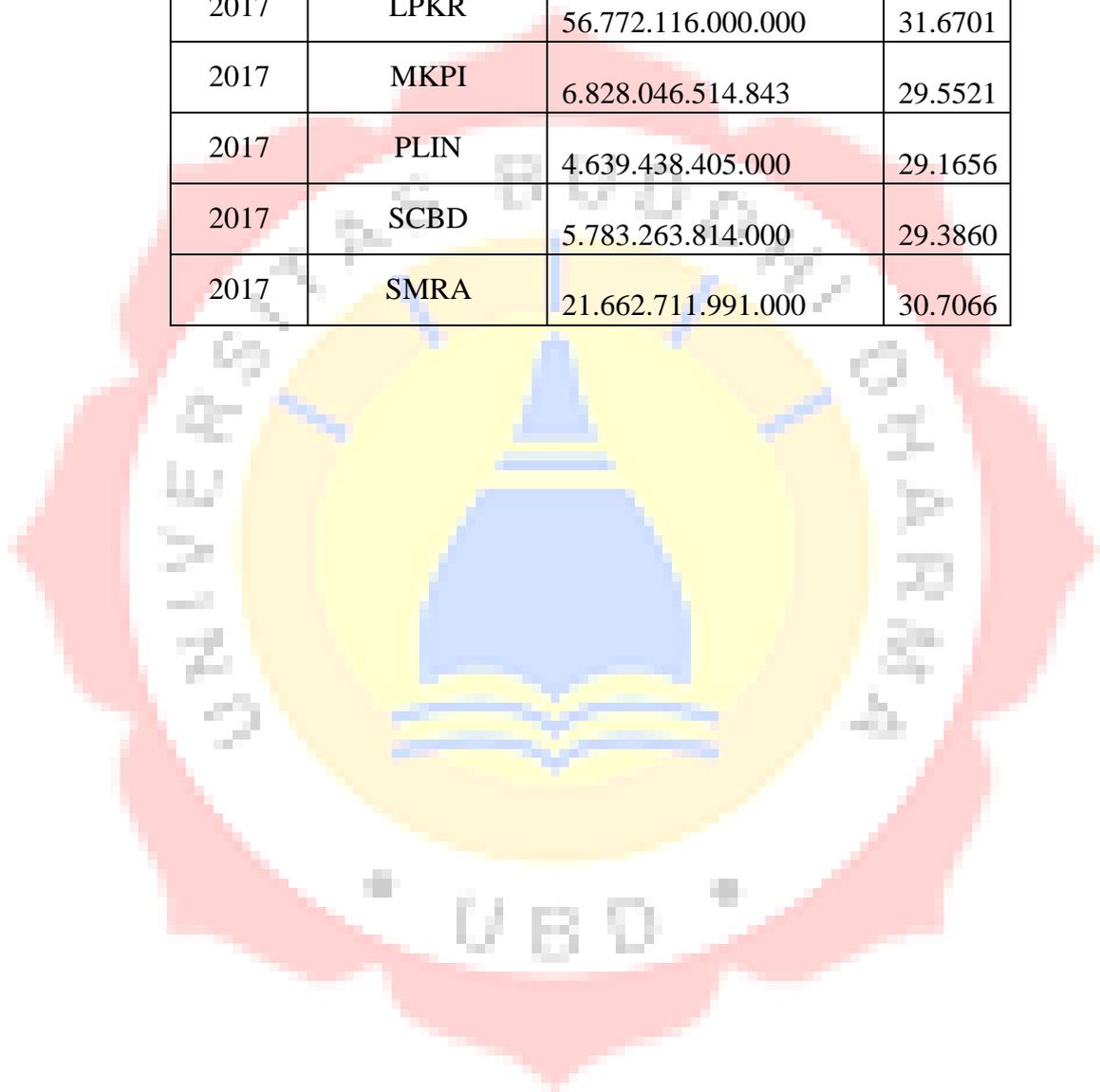

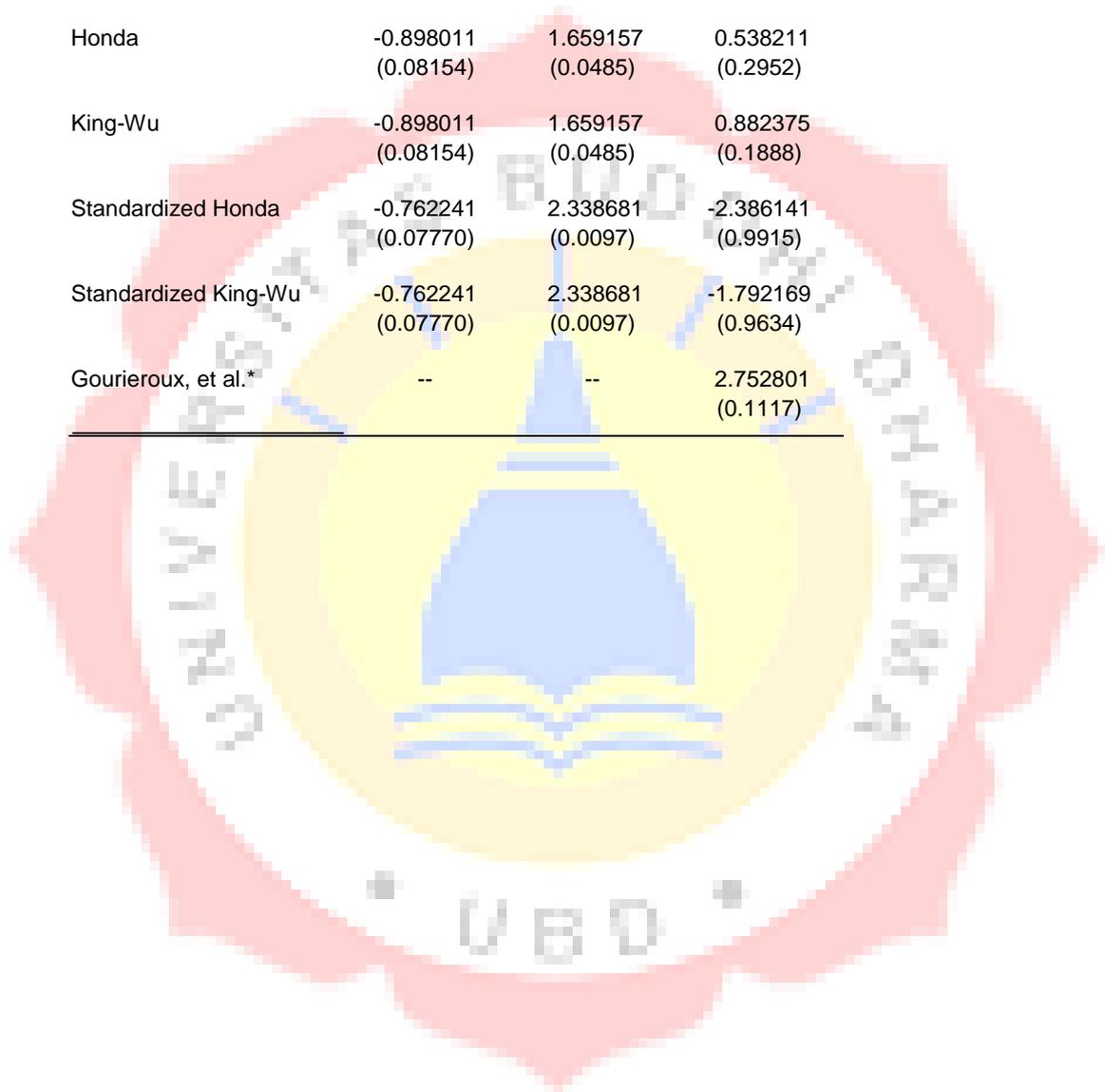
