

The meaning of psychology in literature is explained by Wellek and Warren (1963: 81) as follows: "By 'psychology of literature', we may mean the psychological study of the writer, as type and as individual, or the study of the creative process, or the study of the psychological types and laws present within works of literature, or, finally, the effects of literature upon its readers (audience psychology)".

The psychoanalytic theory developed by Freud has been the most widely used theory to date. How is the personality traits reflected in the character "Antonio Sandoval"?


1.4 Goal and Function

2.1 Previous Studies

The research conducted by Fernando Maramis (2012), from The State Samratulangi University of Manado. His theses entitled "Character analysis in the novel Breaking Dawn by Stephenie Meyer". Based on this research, the writer concludes from the analysis of the characters in the novel Breaking Dawn, this research refers to the character of Edgar V. Roberts (1983) in his book Writing Themes about Literature by paying attention to the dialogues, actions and comments of the characters, can found several traits or characters that reflect themselves from the characters who is in it. These characteristics are: closed, selfsacrificing, self-control, understanding, calm, shrewd, prejudiced, determined, wise, perfectionist, brave, cheerful, dominant, cunning, cowardly, kind, wise, tough, fragile, good friend, caring, unselfish, sensual, temperamental, humble, opinionated, closed, caring, experienced, vigilant, scary, adventurous, patriot and good at teaching. After the writer found the characters in the novel Breaking Dawn, the author conducts an analysis using the characterization method in this novel by using refers to the theory of Laurence Perrine (1959) in his book Story and Structure namely direct presentation and indirect presentation. In the novel Acting Dawn, the author raises six figures analyzed with both direct and indirect theories spresentation, namely: Bella Swan, Edward Cullen, Jacob Black, Charlie Swan, Jasper Hale and Garrett. This is because the six figures are compatible with both methods characterization of Laurence Perrine, direct and indirect presentation.

Abdul Hadiansyah (2016) from State Islamic Sunan Gunung Djati University Bandung carried out the study. His propositions named "A Mental Examination On The Principal Character In the event that I Stay by Gayle Forman". Novel If I Stay by Gayle Forman was chosen by the author to examine the main character's psychological and personality issues on the basis of this research. This study is meant to figure out two focuses; 1) knowing the psychology and personality of the main character, and 2) knowing the factors that affect the main character's personality. This study uses the theory of Sigmund Freud to explain psychoanalysis. The information is taken from an original Gayle Forman's novel On the off chance that I Stay. According to Freud's (1920), there is a conscious part of the mind where people think and are aware of their thoughts. He likewise proposed the possibility of an oblivious piece of the brain, where wants and drives exist that individuals don't know about, yet that influence them and in some cases cause mental issues. One strategy in psychoanalytic scholarly analysis is to regard a work of writing like it is a fantasy. By interpreting the more obvious content, this method aims to comprehend the unconscious symbols and desires. Symbolism and other types of analysis are used in this kind of literary criticism to get at a piece of literature's hidden content. Sigmund Freud structured his psychological theory into three parts, specifically Id, Superego, and Superego. As indicated by Freud's psychoanalytic hypothesis, the id is the crude and instinctual part of the brain that contains sexual and forceful drives and secret recollections, the super-self image works as an ethical still, small voice, and the self image is the sensible part that intervenes between the longings of the id and the super-self image (Mcleod, 2023).

1. Id
