

BAB V

PENUTUP

A. Kesimpulan

Berdasarkan penelitian yang telah dilakukan, penulis mendapatkan kesimpulan mengenai pengaruh secara parsial maupun simultan dari variabel profitabilitas yang diproksikan dengan ROA, *leverage* yang diproksikan dengan DER, dan pertumbuhan penjualan (*sales growth*) terhadap nilai perusahaan yang akan dijabarkan sebagai berikut :

1. Hasil pengujian hipotesis pertama (H_1) terdapat nilai signifikan sebesar $0,000 < 0,05$ dan nilai $t_{hitung} 14,004 > t_{tabel} 1,98861$ maka dapat disimpulkan “secara parsial variabel Profitabilitas diproksikan ROA berpengaruh secara positif dan signifikan terhadap Nilai Perusahaan”.

Uji Koefisien menunjukkan pengaruh profitabilitas sebesar 57.3%, Hal ini disebabkan ROA (*Return On Asset*) merupakan margin keuntungan yang mengukur laba bersih setelah pajak penjualan sehingga semakin tinggi margin laba bersih maka semakin baik kinerja perusahaan untuk memperoleh keuntungan.

2. Hasil pengujian hipotesis kedua (H_2) terdapat nilai signifikan sebesar $0,000 < 0,05$ dan nilai $t_{hitung} 7,926 > t_{tabel} 1,98861$ maka dapat disimpulkan

“secara parsial variabel *Leverage* diproksikan DER berpengaruh secara positif dan signifikan terhadap Nilai Perusahaan”.

Uji Koefisien menunjukkan pengaruh *leverage* sebesar 18%, Hal ini disebabkan DER (*Debt to Equity Ratio*) merupakan rasio untuk mengukur utang relatif terhadap ekuitas, utang yang tinggi disebabkan kebutuhan pembiayaan untuk menjalankan operasional, ekspansi, serta pengembangan sehingga dapat meningkatkan nilai perusahaan.

3. Hasil pengujian hipotesis ketiga (H_3) terdapat nilai signifikan sebesar $0,000 < 0,05$ dan nilai $t_{hitung} -2,021 < t_{tabel} -1,98861$ maka dapat disimpulkan “secara parsial Pertumbuhan penjualan diproksikan *sales growth* berpengaruh secara negatif dan signifikan terhadap Nilai Perusahaan”.

Uji Koefisien menunjukkan pengaruh pertumbuhan penjualan sebesar 20%, Hal ini disebabkan pertumbuhan penjualan pada masa COVID-19 membuat kesulitan dalam perekonomian yang membuat perusahaan menjual produk mereka dibawah harga pasar/rugi yang membuat berbanding terbalik(negatif) dengan nilai perusahaan.

4. Hasil pengujian hipotesis keempat (H_4) terdapat nilai signifikan sebesar $0,000 < 0,05$ dan nilai $F_{hitung} 89,238 > F_{tabel} 2,713227$. Maka dapat disimpulkan “secara simultan (bersama-sama) variabel Profitabilitas, *Leverage*, dan Pertumbuhan Penjualan (H_4) berpengaruh secara positif dan signifikan terhadap Nilai Perusahaan”. Tingkat profitabilitas menunjukkan kemampuan perusahaan menghasilkan laba dalam kegiatan operasinya,

penggunaan *leverage*/hutang digunakan untuk mendanai operasional jika dikelola dengan baik akan menghasilkan keuntungan dimasa depan, pertumbuhan penjualan mencerminkan kinerja dari perusahaan.

B. Saran

1. Bagi Investor

Bagi investor yang akan melakukan investasi diperusahaan, disarankan untuk melihat dan mengkaji lebih awal mengenai informasi profitabilitas yang didapatkan oleh perusahaan, memahami dan mengetahui seberapa besar hutang yang dimiliki oleh perusahaan dan digunakan untuk kegiatan operasional atau lainnya, serta meninjau kembali pertumbuhan penjualan perusahaan sebelum para investor tersebut melakukan pengambilan keputusan untuk berinvestasi pada perusahaan *consumer non-cyclicals* yang terdaftar di Bursa Efek Indonesia.

2. Bagi Perusahaan

Bagi pihak manajemen perusahaan disarankan untuk memperhatikan faktor-faktor dalam penelitian ini yaitu profitabilitas, *leverage*, dan pertumbuhan penjualan untuk digunakan sebagai bahan penilaian ketika menyiapkan kebijakan yang sesuai untuk meraih tujuan perusahaan yaitu menaikkan nilai perusahaan.

3. Bagi Penelitian Yang Akan Datang

- a. Bagi penelitian yang akan datang sebaiknya memperluas ruang lingkup dari subsektor *consumer non-cyclicals* saja, tetapi juga dapat memakai subsektor atau sektor lain sehingga memiliki cakupan yang baru atau lebih luas. Selain itu penelitian ini sebaiknya diperpanjang agar dapat memperkuat hasil penelitian.
- b. Bagi penelitian yang akan datang sebaiknya menggunakan variabel lainnya yang berkaitan untuk mengetahui pengaruhnya terhadap nilai perusahaan, seperti solvabilitas, pertumbuhan pendapatan, pertumbuhan laba per saham, rasio lancar atau rasio cepat dan lainnya.
- c. Bagi penelitian yang akan datang sebaiknya mencoba mensubstitusi variabel nilai perusahaan lainnya selain menggunakan PBV seperti Tobin's Q atau *Price to Earning Ratio* (PER).

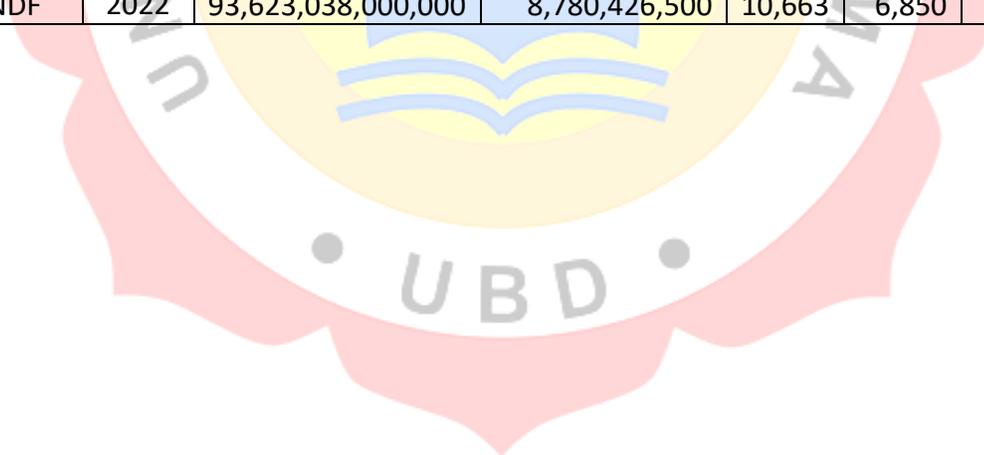

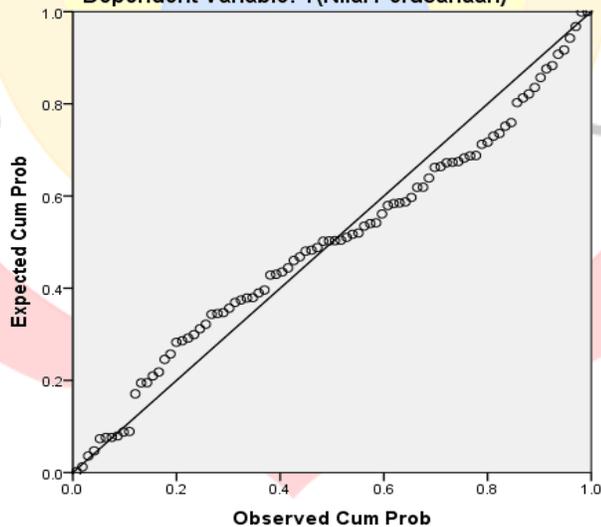

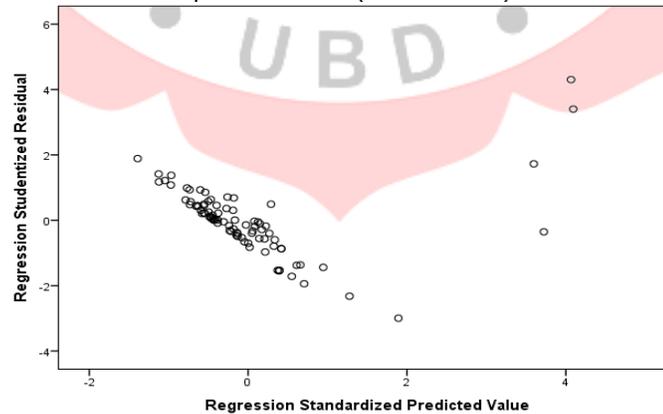
