

BAB V

PENUTUP

A. Kesimpulan

Berdasarkan hasil penelitian yang dilakukan oleh penulis mengenai pengaruh profitabilitas, ukuran perusahaan, komite audit, dan *professional fee* terhadap *audit delay* pada perusahaan sektor *consumer non-cyclicals* yang terdaftar di BEI pada tahun 2020-2022. Penelitian ini menggunakan data sampel dari 69 perusahaan sektor *consumer non-cyclicals* yang terdaftar di Bursa Efek Indonesia. Dari hasil pengujian ini menggunakan *software SPSS (Statistical Program for Social Science)* versi 29 maka hasil tersebut dapat disimpulkan sebagai berikut:

1. Dari hasil pengujian hipotesis pertama (H_1) dapat disimpulkan secara parsial variabel profitabilitas (GPM) berpengaruh negatif dan signifikan terhadap *audit delay* dengan nilai signifikan sebesar $0.001 < 0.05$ dan nilai t-hitung $-6.274 > t\text{-tabel } 1.97178$ maka (H_1) yang telah ditetapkan dapat diterima.
2. Dari hasil pengujian pada hipotesis kedua (H_2) dapat disimpulkan secara parsial variabel ukuran perusahaan berpengaruh negatif dan signifikan terhadap *audit delay* dengan nilai signifikan sebesar $0.001 < 0.05$ dan nilai t-hitung $-4.942 > t\text{-tabel } 1.97178$ maka (H_2) yang telah ditetapkan dapat diterima.
3. Dari hasil pengujian pada hipotesis ketiga (H_3) dapat disimpulkan secara parsial variabel komite audit berpengaruh negatif dan signifikan terhadap

audit delay dengan nilai signifikan sebesar $0.006 < 0.05$ dan nilai t-hitung - $2.764 > t\text{-tabel } 1.97178$ maka (H_3) yang telah ditetapkan dapat diterima.

4. Dari hasil pengujian pada hipotesis keempat (H_4) dapat disimpulkan secara parsial variabel *professional fee* berpengaruh negatif dan signifikan terhadap *audit delay* dengan nilai signifikan sebesar $0.001 > 0.05$ dan nilai t-hitung - $5.665 > t\text{-tabel } 1.97178$ maka (H_4) yang telah ditetapkan dapat diterima.
5. Dari hasil pengujian hipotesis kelima, berdasarkan uji simultan (uji f) menunjukkan profitabilitas, ukuran perusahaan, komite audit, dan *professional fee* terhadap *audit delay*. Hal ini dibuktikan dengan nilai sig sebesar $0.001 < 0.05$ dan f-hitung sebesar $20.249 > F\text{-tabel } 2.42$ maka (H_5) yang telah ditetapkan dapat diterima.

B. Saran

Hasil penelitian ini dapat dijadikan sebagai sumber referensi bagi pihak-pihak yang membutuhkan ataupun peneliti selanjutnya. Maka dari itu dalam penelitian ini terdapat beberapa saran sebagai berikut:

1. Bagi Perusahaan

Hasil penelitian ini diharapkan dapat membantu pihak manajemen perusahaan yang memiliki masalah dalam keterlambatan laporan keuangan maupun yang menginginkan untuk dapat melaporkan laporan auditnya secara lebih cepat, pada penelitian ini terdapat 4 variabel yang dapat membantu untuk bisa mempersingkatnya *audit delay* yaitu profitabilitas: semakin tingginya profitabilitas dapat mengurangi lamanya audit karena

perusahaan dapat menggunakan jasa audit yang lebih baik, ukuran perusahaan: ukuran perusahaan yang besar dapat mempersingkat *audit delay* hal ini dikarenakan memiliki sumber daya manusia yang banyak sehingga mampu mempersingkat *audit delay*, komite audit: perusahaan dapat mempersingkat *audit delay* dengan memiliki komite audit karena komite audit yang menjalankan fungsi dengan baik dapat mempersingkat masa *audit delay*, dan *professional fee*: semakin besar *fee* yang diberikan auditor mampu mempersingkat *audit delay* hal dikarenakan tanggung jawab yang lebih besar dan tingkat *litigasi* yang diberikan kepada auditor. Diharapkan dengan penelitian ini mampu membantu untuk pihak manajemen perusahaan agar tidak mengalami keterlambatan keuangan dan menentukan kebijakan perusahaan sehingga dapat mempersingkat proses pelaksanaan audit untuk melakukan pelaporan kepada Bursa Efek Indonesia (BEI), investor, dan pihak berkepentingan lainnya.

2. Bagi Investor

Hasil penelitian diharapkan dapat membantu investor untuk membuat keputusan investasi yang lebih baik yang dimana perusahaan yang tidak mengalami keterlambatan dan dapat mempublikasi laporan keuangan yang lebih awal dapat menguntungkan investor untuk dapat mempertimbang untuk keputusan investasi yang lebih awal dan lebih matang dalam melakukan investasi, tentunya perusahaan yang lebih cepat dalam menyampaikan laporan keuangan yang cepat dan tepat waktu cenderung memiliki komite audit yang handal sehingga laporan keuangan

dihasilkan lebih baik karena diawasi dengan baik sehingga dapat menghasilkan keputusan investasi yang tepat dan dapat dipercaya.

3. Bagi Peneliti Selanjutnya

Dalam hasil penelitian yang dilakukan oleh penulis diharapkan dapat menjadi bahan referensi bagi penelitian selanjutnya serta dapat memberikan kontribusi bagi pengembangan ilmu dan pemahaman khususnya di bidang pemeriksaan audit tentang pengaruh profitabilitas, ukuran perusahaan, komite audit, dan *professional fee* terhadap *audit delay* pada perusahaan *consumer non-cyclicals* yang terdaftar di Bursa Efek Indonesia (BEI) tahun 2020-2022. Peneliti selanjutnya diharapkan dapat melakukan penelitian pada perusahaan yang bergerak di sektor lainnya, menambahkan dan memperbarui periode tahun yang diteliti dengan variabel berbeda dari yang penulis telah lakukan dan dapat menambah variabel *intervening* ataupun *moderating* yang diteliti sehingga dapat menganalisa variabel lain yang mempengaruhi *audit delay* dan memperkuat ataupun memperlemah hubungan langsung maupun tidak langsung antara variabel independen dan dependen

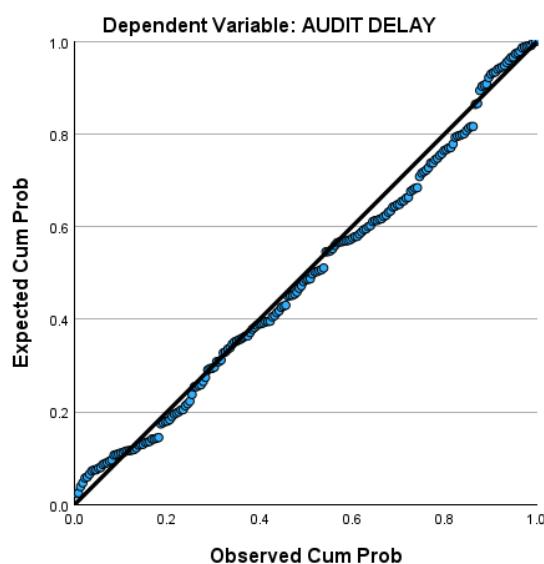

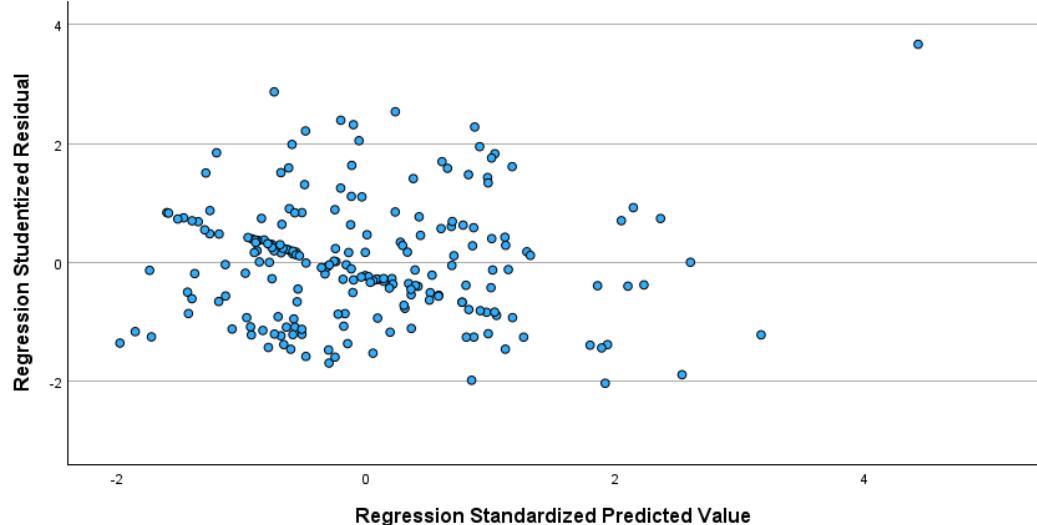
