

BAB V

PENUTUP

A. Kesimpulan

Berdasarkan hasil penelitian dan pengolahan data yang didukung dengan menggunakan program SPSS versi 29 mengenai Pengaruh *Capital Intensity Ratio*, *Leverage*, Profitabilitas, dan Ukuran Perusahaan Terhadap Manajemen Pajak Studi Pada Perusahaan Sektor Properti dan Real Estate yang terdaftar di Bursa Efek Indonesia (BEI) Periode 2018-2022. Data sampel yang digunakan ada 10 perusahaan dikali 5 tahun periode penelitian. Dapat dirangkum hasil analisis dan pembahasan yang telah diuraikan pada BAB IV diatas, dengan kesimpulan sebagai berikut:

1. *Capital Intensity Ratio* yang diukur menggunakan CIR dengan membandingkan total aset tetap bagi total aset, mendapatkan hasil tidak berpengaruh signifikan terhadap Manajemen Pajak.
2. *Leverage* yang diukur menggunakan *Debt to Equity Ratio* (DER) dengan membandingkan total utang bagi total ekuitas, hasilnya bahwa *Leverage* berpengaruh signifikan terhadap Manajemen Pajak.
3. Profitabilitas diukur menggunakan *Return On Assets* (ROA) dengan membandingkan laba bersih setelah pajak bagi total aset, mendapatkan hasil Profitabilitas tidak berpengaruh signifikan terhadap Manajemen Pajak.

4. Ukuran Perusahaan diukur menggunakan Logaritma *Natural* (Ln) total aset (*SIZE*), mendapatkan hasil Ukuran Perusahaan tidak berpengaruh signifikan terhadap Manajemen Pajak.
5. Hasil pengujian secara simultan (Uji Statistik F) menunjukkan bahwa nilai signifikansi lebih kecil dari tingkat signifikansi 0,05 yaitu ($0,008 < 0,05$). Maka H_0 ditolak dan H_a diterima yang artinya variabel *capital intensity ratio*, *leverage*, profitabilitas, dan ukuran perusahaan secara bersama-sama berpengaruh signifikan terhadap variabel dependen yaitu manajemen pajak menggunakan proksi *effective tax rate* (ETR).

B. Saran

Saran yang dapat dirincikan mengenai penelitian ini adalah sebagai berikut:

1. Bagi Akademik

Agar materi pengajaran dalam bidang perpajakan di Universitas dapat dilengkapi dengan peraturan perundang-undangan perpajakan yang terbaru, dan dapat digunakan sebagai sumber penelitian bagi mahasiswa yang sedang membaca penelitian ini.

Disarankan untuk peneliti selanjutnya diharapkan dapat menggunakan variabel-variabel lain yang mungkin memiliki pengaruh terhadap manajemen pajak, seperti kepemilikan institusional, *inventory intensity*, komisaris independen, dewan ukuran komisaris. Serta menggunakan objek penelitian dari perusahaan-perusahaan sektor-sektor lainnya yaitu perusahaan manufaktur di industri barang konsumsi, sektor

industri dasar dan kimia, serta berbagai sektor industri atau subsektor di dalam sektor-sektor tersebut.

2. Bagi Pemerintah

Bagi Direktorat Jenderal Pajak (DJP) Kementerian Keuangan di Indonesia dapat dijadikan sebagai bahan masukan untuk menyusun kebijakan dan menetapkan peraturan perpajakan yang telah dibuat, selain itu menambah pengawasan terhadap subjek pajak supaya tidak terjadi kecurangan dalam menentukan tarif pajak efektif perusahaan.

3. Bagi Perusahaan

Berdasarkan hasil penelitian leverage berpengaruh terhadap manajemen pajak, hal ini membuktikan bahwa dengan nilai DER yang tinggi, berarti memiliki biaya bunga pinjaman yang tinggi, hal tersebut dimanfaatkan oleh perusahaan untuk mengurangi laba fiskal maka beban pajak pun semakin kecil. Perusahaan melakukan pengelolaan hutang, pengendalian, pengawasan, dan perencanaan terkait pajak demi keberlangsungan hidup perusahaan. Selanjutnya dalam rangka membantu manajemen menciptakan kerangka kerja yang kuat untuk menjalankan operasi perusahaan yang berkelanjutan, hal ini dapat menjadi alat yang berguna untuk memberikan wawasan, pengetahuan, dan edukasi mengenai perencanaan pajak. Bagi para investor agar dapat mengetahui perilaku manajemen atau perencanaan pajak dari pelaku usaha dan dapat mempertimbangkan resikonya bagi posisi kepemilikan saham di perusahaan tersebut.

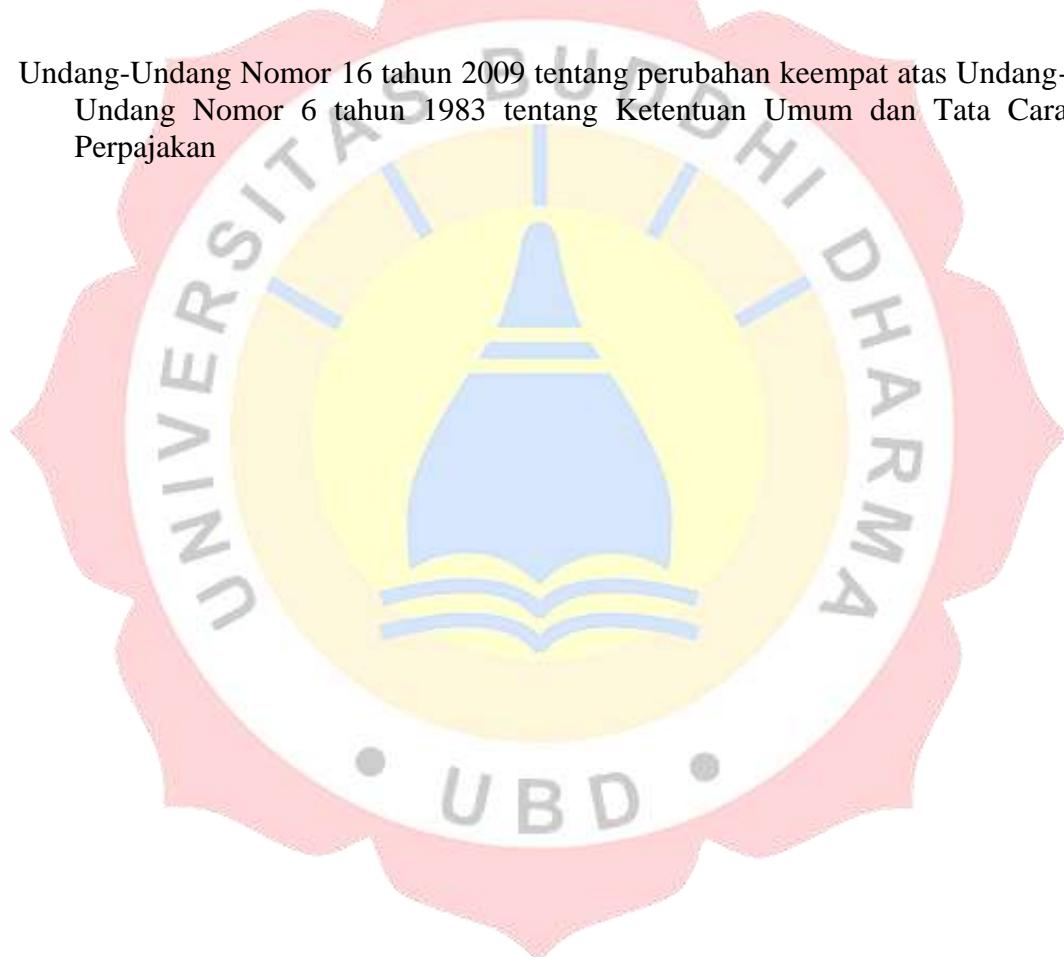

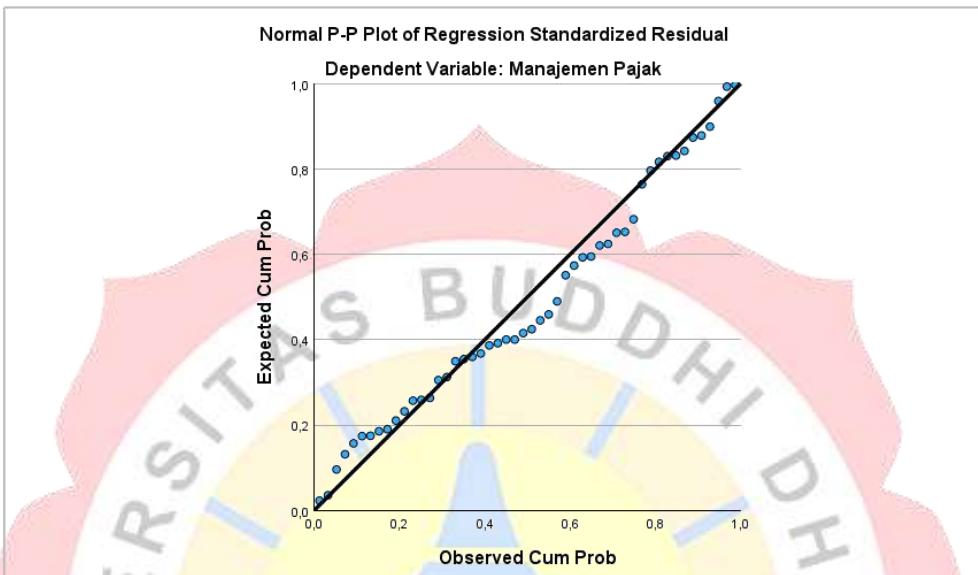

3. Hasil Uji Normalitas P-Plot

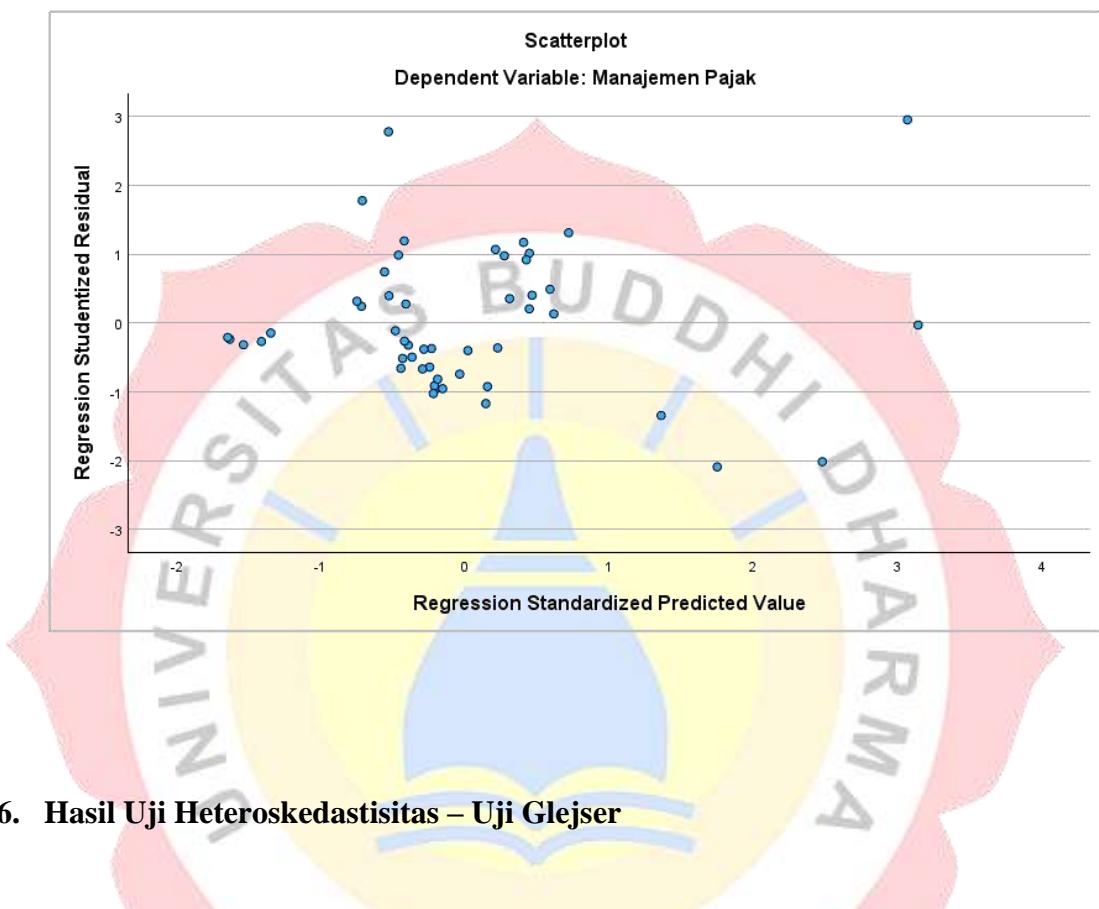

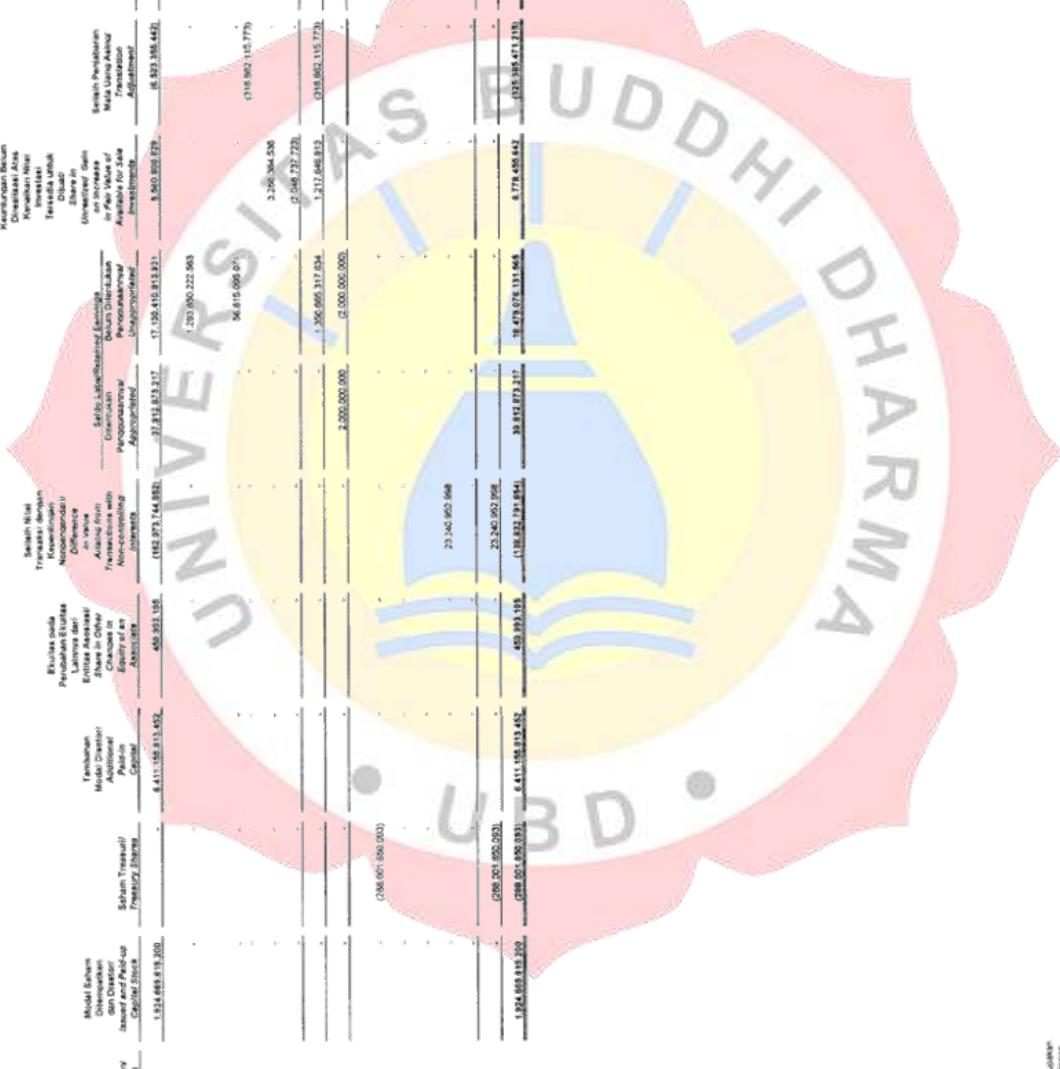
